To impart induction training to the newly recruited Judicial Officers; ii. To impart refresher and orientation training and education to Judicial Officers; iii. To provide training to the ministerial staff of the judicial court from time to time; iv. To provide such other judicial trainings and education related services, as may be necessary, to improve the efficiency of the justice delivery system; v.
