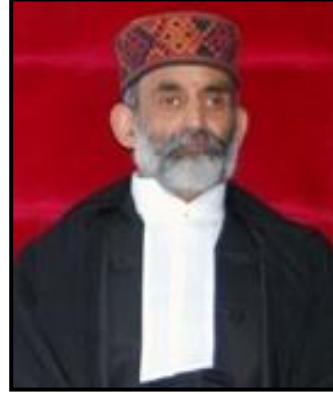

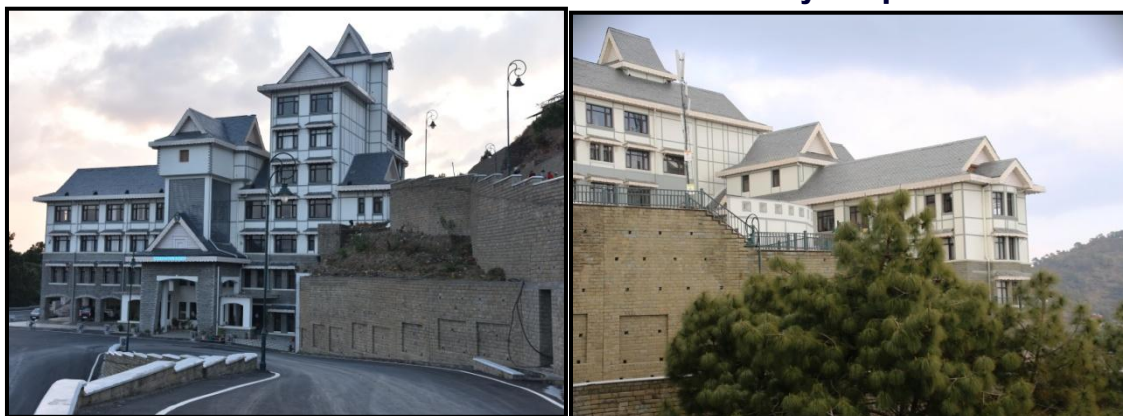
ACADEMY NEWS

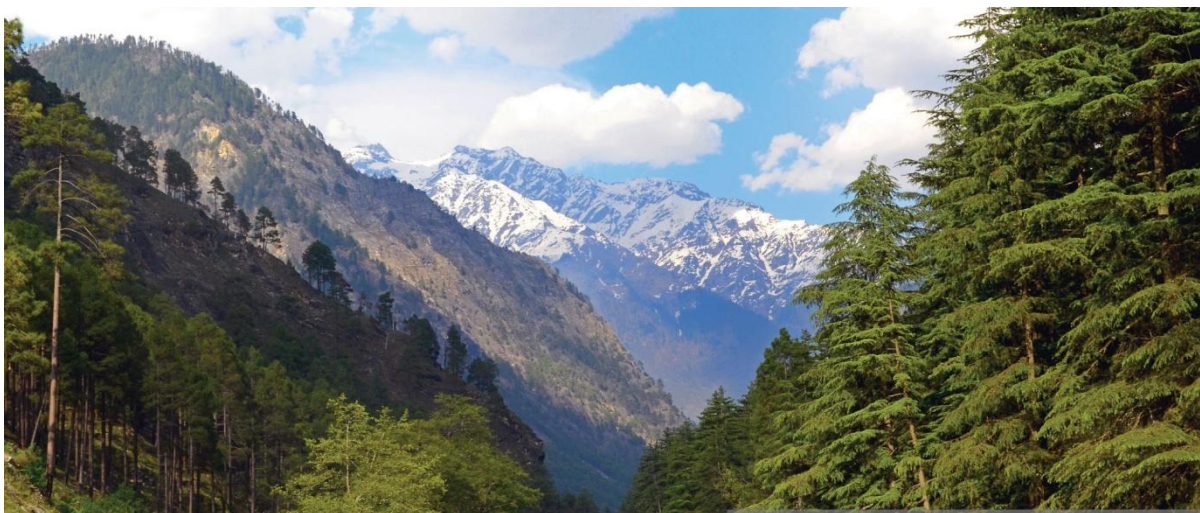

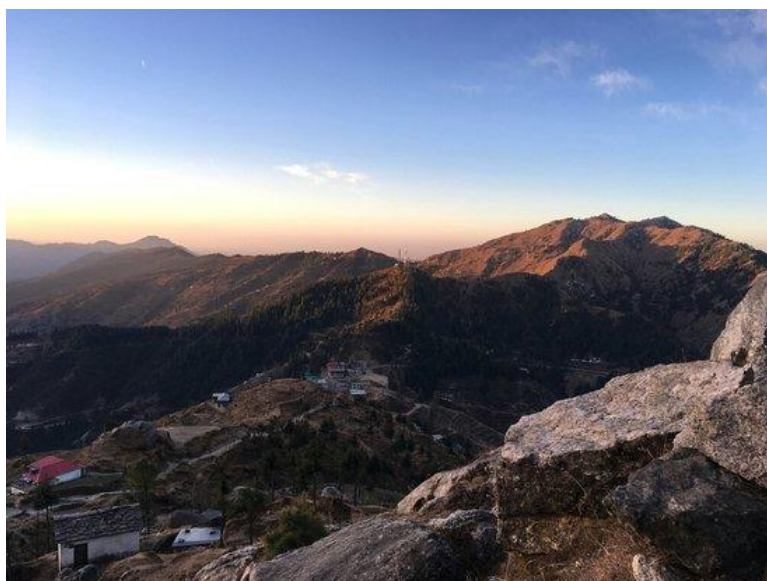
